### Goods Carrying Vehicle Private

### Registration Fees

(100% Input Tax Credit Entitlement)

A goods carrying vehicle is defined as a motor vehicle constructed principally for the carriage of goods, where the vehicles tare weight does not exceed 4500 kg. For Example: light truck (utility), or van.
