Trucks Type 1 and 2 Registration Fees

(100% Input Tax Credit Entitlement)

A truck is defined as a rigid motor vehicle that is principally constructed as a load-carrying vehicle where the tare weight exceeds 4500 kg. A truck can be one of two types:

Truck Type 1

A truck type 1 is defined as a truck that:

- has 2 axles and a Gross Vehicle Mass (GVM) not exceeding 12 tonnes; or
- has 3 axles and a GVM not exceeding 16.5 tonnes; or
- has 4 or more axles and a GVM not exceeding 20 tonnes.

Truck Type 2

A truck type 2 is defines as a truck that:

- has 2 axles and a GVM exceeding 12 tonnes; or
- has 3 axles and a GVM exceeding 16.5 tonnes; or
- has 4 or more axles and a GVM exceeding 20 tonnes.
